  - 5.5 Provide knowledge of surveillance and anti-corruption to the director, all teachers and educational personnel to make students, their parents and people in community to aware and participate in anti-corruption activities in Phase 3 (2017 – 2021).
  - 5.6 Make the indexing measure of virtue and transparency for Wangphrongphithayakhom School and follow the guidelines in accordance with National Strategy on Anit- Corruption Phase 3 (2017 – 2021).
  - 5.7 Make the way of communication, dissemination and public relation to support operations as a network of anti-corruption cooperation.
